Thank you for registering for Day Camp at the Girl Scout Program Center! Our camp encourages girls to build courage, confidence, and character as they engage in fun, hands-on, girl led activities in a safe environment. ### Registration

To complete your camper's registration, the following forms must be completed and returned to Customer Care AND payment in full must be made **no later than two weeks prior to the beginning of the camp session**. The forms can be emailed to [customercare@gsewni.org](mailto:customercare@gsewni.org) or dropped off/mailed to Girl Scouts, 1404 N. Ash, Spokane, WA 99201.

- **Code of Conduct:** The behavior agreement that all campers and families sign, agreeing to abide by camp and council rules.
- **Camper Release:** Grants permission for camper to be picked up from camp. Please list any possible person who may pick up your camper in the case of emergency. Changes will not be accepted via phone.
- **Health History:** Each camper is required to have a health history form.

### Packing List

Please check the weather daily and send your camper with weather appropriate clothing. We may go on walking field trips throughout the year, rain or shine!

### Daily Arrival/Departure

Our camp program runs from 9:00 am to 4:00 pm. Please drop your child off between 9:00 and 9:15 so that they can get the full camp experience each day. If you need extended hours before or after camp, they are available for an additional fee, which may be applied automatically if you drop off or pick up between 7:30-9:00am or from 4:00-5:30pm. When you arrive, you will need to sign your camper in with your signature and arrival time. Similarly, when you pick your camper up, they will need to be checked out by an authorized adult. We WILL NOT release a camper without proper ID from those picking them up. If you need to pick up your child before 3:45pm or contact your camper during the day, please call the office to let us know.
